### Facilitator Responsibilities:

#### 1. Facilitation:

- Provide a 30-minute session to each rotating group of attendees. Your session should align with the wellness/personal development theme and provide valuable insights, knowledge, or experiences.
- Your presentation should be designed to engage your audience and provide an experience.
- Ensure your materials, tools, and any setup requirements are prepared before the event starts. *(Note: There is no electricity for most vendors although we could provide it for possibly 1 if absolutely necessary)*

## 2. Promotion:

- Promote the event through your business/social media platforms and networks to help drive ticket sales.
- *Ideally each facilitator would work to sell at least 4 tickets for a successful event*
- Share the provided promotional content via email, socials and in-person if applicable.

## 3. Commitment:

- Attend the event (or backup date) and fully participate throughout the day.
- Sign and return this contract along with your facilitator fee by **August 21st, 2025**.

## 4. Logistics:

- Arrive at the venue between **7:00-8:00 AM** on the event day for setup and preparation. The event starts promptly at 9:00 AM. (Guests check in between 8:30-8:50am)
- **Bring any supplies or materials needed for your session (discuss details with event organizers if anything [ie: chairs, yoga mats, etc] needs to be provided).**
- Be flexible and work within the provided event schedule to ensure smooth group transitions.
- The event will conclude at 5:30 PM. All items must be packed up and removed from the property following the event.
- NOTE: There will be no electricity available.

## Payment Terms:

The Aquarian Acres is committed to doing things differently and growing a new kind of community, and that includes financially. We want everyone to feel like they can share in the community and receive abundance. For that reason, we feel proud to introduce Profit Sharing!

### 1. Revenue Share:

- Ticket sales will be divided into two parts:
  - 40% for event venue/organizers.
  - 60% for facilitators, split evenly among all 9 participating facilitators.
- Final payment to facilitators will be made no later than 30 days following the event, once ticket sales and expenses are reconciled.
- Ticket prices are set for this event at \$111
- The more we share the event and change people's lives, the more we share in the abundant financial energy exchange!

## 2. Facilitator Reservation Fee:

- To secure your spot as a facilitator, a **non-refundable reservation fee of \$77** is required upon signing this contract.
  - This fee will help cover marketing and organizational expenses and ensure commitment from all facilitators.
  - Payment Deadline: **August 21st, 2025.**

- **This is an outdoor event, and electricity will not be available** at the venue. (We could do 1 facilitator if absolutely necessary for your business)
  - Facilitators are responsible for bringing their own equipment and setting up any tents or shade structures needed for their session.
  - The Aquarian Acres will provide assistance to your location on the property.
  - We recommend preparing for all weather conditions and bringing necessary materials to ensure the comfort of yourself and attendees.
