Program Stails

Training materials are made available through the Kartra platform. There is also a private Facebook group, with weekly Facebook Live presentations to review the materials and provide an opportunity for participants to post questions, which will be answered during the Live.

To fully participate in the Program, it is recommended that you set aside around 2 hours per week for 6 weeks to complete the Program content without falling behind. You will also need a Facebook account and sufficient internet to view the presentations either Live or as a recording.

Expected dates and times for the Live presentations are set out in the Facebook group.

You have access to the Program materials on Karta for 12 months. The Facebook group closes down 4 weeks after the end of the Program. However, it reopens with each new round of the Program. Previous participants are welcome to stay a member of the group and access the ongoing Lives and ability to ask questions that arises each time the Program is offered.

Mutual Responsibilities

I have a diploma of Applied Science and a diploma of Remedial Therapies. This Program has been developed from my clinical experience in treating thyroid conditions over the last 25+ years. - ask thoughtful questions about implementing the materials in real life scenarios.

Occasionally, technical issues may interfere with delivery of the Program. If that occurs, I ask for your patience and understanding while the troubleshooting process takes place.

This Program is solely focused on thyroid conditions and thyroid health. It offers a deep dive into the complexity of thyroid conditions from the perspective of a practitioner who exclusively treats thyroid issues in clinic.

If we are unable to resolve a dispute by negotiation and discussion within 14 days, we agree to proceed to mediation with the assistance of an independent accredited mediator, seeking online dispute resolution or mediation by telephone if we are not both in the Margaret River region of Western Australia.

The mediator is to be appointed by agreement between us or, failing agreement within 21 days of the negotiation period ending, the person initiating the dispute will seek the appointment of a dispute resolution professional by the WA Small Business Commissioner.

We agree to share all the costs of mediation equally between us.

We agree that neither of us will commence legal action until, in the opinion of the independent mediator, the potential for negotiation and mediation have been exhausted.

We agreement agree that we will not publicly or privately disparage each other and will act in good faith to refrain from any conduct or communication which might reasonably be expected to interfere with each other's business or personal interests.

This agreement is subject to the governing law of Western Australia. Regardless of where you live in the world, you irrevocably agree that if the dispute resolution processes fail, the courts of Western Australia, and the Commonwealth of Australia, will have exclusive jurisdiction.
